Collection Description

Biographical/historical note

Richard F. Yeager was a captain with noted guerrilla fighter William C. Quantrill and served with him beginning in 1862 in the Kansas and Missouri border area. His father was James Yeager who at one time was a presiding judge of the Jackson County Court and a freighter on the Santa Fe Trail. Richard Yeager was in charge of one of his father's wagon trains. He died in 1864.

Upton Hayes was born in Callaway County, Missouri in 1832. He lived in Westport, Missouri in Jackson County and was a relative of Daniel Boone. He fought with the Confederacy and was commissioned as a captain of cavalry in 1861. He was to raise troops in and around Westport, which he did and they became involved in defending the property of southern sympathizers in Jackson County and vicinity. He was killed in the Battle of Newtonia in 1864.

William C. Quantrill was a noted guerrilla fighter during the Civil War period of history along the Kansas and Missouri border. He lead raids, the most noted being the raid on Lawrence, Kansas in 1863 with the massacre of male citizens that followed. He was born in 1837 in Dover, Ohio and died in 1865 in Kentucky.

Scope and content note

This small two-folder collection contains six items which include a ledger book, account receipts, a proclamation, a permit, and an oath of allegiance. The dates range from 1861 to 1865. All but one item, the ledger book, have some relation to

the Civil War period. Three of the collection items pertain to Richard F. Yeager (Yager), one to Upton Hayes and William Quantrill, one to Edward F. West, and one is unidentified.

We proclaim to all men if they will come to any of the many camps, now in the brush they will be furnished with arms, and ammunition, with which to Any one who shall be found guilty of reporting to any military post, the whereabouts of any southern man shall be shot. Any one liable to military duty who shall leave the state or shall be found preparing to leave the state to prevent being called into the service will be deemed enemies of the "South", and treated accordingly. To the state of Missouri, Aug. 4th '62 Upton Hays W.C. Quantrill.
