Mary Handly Linton Papers and Slide Collection

This collection of slides and personal papers came from the estate of Mary E. Handly Linton, local poet and author.

Collection Description

Biographical/Historical note

Mary Elizabeth Handly Linton was a local poet and author. She was born on September 6, 1910, in Jackson County, Missouri, the only child of Eugene S. and Kate Handly. Edgar Linton and Mary were married on November 20, 1932 in Jackson County, Missouri. Mary worked for the Radial Warehouse Company in North Kansas City for many years. It appears that she was a natural poet and as she developed her talent many of her poems were published in newspapers and magazines as well as in book form.

For many years, the *Kansas City Star* published many of her poems in the poetry corner located on the editorial page. She wrote *On Wings of the Soul* (1947) and *Roads Wide With Wonder: A Collection of Poems* (1954), books of poetry. According to a newspaper article published in the *Kansas City Star*, September 3, 1947, Mary Linton states, "my experiments with a camera, and a fairly large collection of classical records rank close to poetry among my interests."

Mary Linton was also an active member of the Kansas City Quill Club and was elected chairperson of the Poets' Round Table of the Kansas City Quill Club. According to the Social Security Death Index, Mrs. Linton died February 1, 1992. An obituary was not located for her in the local newspaper.

Scope and content note

This collection contains photographs both loose and in an album, slides and travel presentations, various family related papers, correspondence, newspaper clippings, book drafts, miscellaneous papers, and unpublished poems. Two of Mary Linton's poetry books are available in Special Collections.

The slide collection is divided into three sections: (1) travel slides and presentations as Mary Linton organized them for presentations; (2) general slide notebook that Ms. Linton compiled herself; (3) general slides chosen from her entire collection for their quality, artistic value, or important or interesting content.

Ms. Linton enjoyed travel and was a very good amateur photographer. Her travel slides reflect her love of the American West and Southwest, especially the mountains and other natural monuments such as Mesa Verde and Oak Creek Canyon in Arizona. One of her slide presentations, titled "Our Living Land" contains many Kansas City statues and buildings as well. These presentations were left intact as Ms. Linton compiled them.

Mary Linton compiled a slide notebook of her work covering many subjects. Perhaps this was a collection of what she considered her best work. Slides 41-60 are unfortunately missing; slide 161 was "sold" but here is no indication to whom. This notebook was left intact as she compiled it. Currently is not found with collection.

The general slide collection truly reflects the type of photography and scenery that Mary Linton enjoyed. The slides in this collection were chosen from her total collection as reflecting some of her best work and some of the more important people and places that she photographed. Often the slides found in her complete collection were slides that she had purchased on trips and had probably incorporated into a few of her slide presentations. These slides were left out, as were those of poor quality, those that were duplicates of other slides chosen to remain in the collection, and those that were not identifiable as adding meaning or importance to this collection.

The general headings in this collection came about rather naturally, and they reflect her interest in the natural world and in the Kansas City area. Mary Linton obviously enjoyed flowers; the many beautiful selections of slides kept here will attest to that. She lived near downtown Kansas City, Missouri, and thus took an interest in area parks and in documenting views and construction in the downtown area. A few photographs of her building, at 929 Jefferson Street, and a few views from her apartment window are included in this collection and add a bit of perspective to her work and her daily life. Included in the "People" section are numerous slides of Ms. Linton herself, taken as early as the 1950s through the 1980s.

For the travel slides, each presentation that Ms. Linton left intact has been given a code of 2 letters that relates to the title of the presentation. These codes and consecutive numbers are in the upper right-hand corner of each slide and are intended to help prevent disarray or easy reordering of the slides should they be removed from order.

For the general slides, each general heading has been given a code letter or letters that relates to the general subject of an entire group of slides. There are sub-dividers within many sections, but the numbering is consecutive throughout each general heading, not within each sub-group. Again, the main purpose of this numbering system is in case of disorder of the slides, whether it be through use of the collection or through accidental disarray. The person processing the

collection did any writing done on the front of the slides in pencil. Often this will give a clue as to what is in the slide without having to view it. Any writing that was done in pen, usually blue ballpoint, was done by Ms. Linton, and it also often gives a description of what is on the slide or when it was taken.
