James A. Hazlett was superintendent of the Kansas City School District from 1955 to 1969. He was leading the school district when desegregation first became an issue.

Collection Description

Biographical/Historical note

James A. Hazlett was superintendent of the Kansas City School District from 1955 to 1969. Prior to this appointment, he was a teacher, principal and director of research for the school district. He was born on May 26, 1917, in Kansas City and died in the same city on September 14, 1997. Dr. Hazlett received all his pre-doctorial education in Kansas City and received his doctorate from the University of Kansas. He became superintendent in Kansas City soon after the landmark school desegregation case, Topeka vs. the Board of Education, and was associated with the district during its early struggles for school desegregation.

After leaving the Kansas City School District in 1969, Dr. Hazlett moved to Denver, Colorado, to work as administrative director of the Education Commission of the States and chairmen of the policy committee of the National Assessment Program. After his stay in Colorado he returned to Kansas City and was employed by the Forrest T. Jones and Company insurance agency where he specialized in the administration of insurance programs for educator associations.

Scope and content note

The collection consists of books, photographs, manuscripts, speeches, correspondence, tape recordings, magazine articles, newspaper clippings, brochures, papers, reports, maps, note cards and various personal items and ephemeral material. Subjects deal primarily with education locally and in general as well as local historical subjects.

Noteworthy materials found in this collection include many of Dr. Hazlett's writings including his educational degree works, the manuscript to an unpublished book entitled "Toward Higher Partnership Relations In Public Education," some of his speeches, reel-to-reel tape recordings of presentations to teachers meetings in the district, some correspondence, and other papers which he produced. Educational related articles as well as local history related newspaper clippings were in his files. Also are found personal items as school diplomas, selective service draft papers, awards and honors, his resume, and his published obituary.

Of particular significance to the history of desegregation in this time period is the three folders of material concerning the middle school controversy experienced in the mid to late 1960s in the Kansas City School District. These files contain correspondence, reports, news releases from all sides in the situation including the NAACP and CORE. Dr. Hazlett's testimony to the House Select Committee of the Missouri House of Representatives given in April 1989 is also in the collection, found with the correspondence, 1984-1989. His testimony to the House Labor, Health, Education and Welfare Subcommittee on Appropriations, May 13, 1974, can also be found in the Education Commission of the States folder.

Dr. James Hazlett's wife, Mary Quinn Hazlett, donated the material and it was picked up on two separate occasions from her home in south Kansas City. She had gone through some of the material and had laid things out. Therefore, the original organization of the collection was not available when brought into Special Collections. The processor has thus arranged the material in folders by general topics and arranged these folders in alphabetical order.
