Historical Sketch

Pioneer Park is located on an island in the intersection of Broadway and Westport Road in the Westport area of Kansas City, Missouri. The land was previously used as a trolley stop. The park commemorates the early history of Westport, a forerunner to the city of Kansas City that was annexed in 1897. There are three historical figures important to the growth of the area depicted in the park's statuary created by local sculptor Tom Beard: Alexander Majors, John C. McCoy, and Jim Bridger.

Initial efforts toward the formation of the park began in 1983 as a memorial to a victim of the Hyatt Regency Skywalk collapse before moving to a commemoration of Westport's founders. Both the Native Sons of Kansas City and the Westport Historical Society were particularly involved in the Pioneer Park Committee. The park was dedicated on October 19, 1987.

Scope and Content Note

This collection was assembled by Fred Lee and gifted to Missouri Valley Special Collections in December 1991. The collection includes photographs, newspaper clippings, correspondence, unofficial meeting minutes and reports, brochures, agreements, a typed chronology of events, and other miscellaneous material. Content includes information on selection of statuary and markers, interaction with the City Council and Parks Department, fundraising efforts, and vendor selection.
