Collection Description

Scope and content note

At the time of its receipt, the collection consisted of 122 mounted color photographs and four panels of textual background information from the period when the photographs were on public display. The photographs depict winners of a biannual award for excellence in urban design granted by the Kansas City, Missouri Municipal Art Commission from 1964 through 1988. The photos document buildings, neighborhoods, parks, signage, streetscapes, gardens, and other features of the built environment that were considered to have enhanced the visual beauty of the city.

The collection was processed in August, 2005, when each print was placed in a stable, acid free environment. All the photographs in the collection are 8" x 10" color prints. When received by the library, each had been mounted for public exhibit. These mountings varied in material from tape and cardboard to foam core, each frame measuring approximately 15" x 15". Many of these mountings were showing considerable wear, and it was decided that the best strategy for long term preservation of the prints was to remove them from the frames. In most cases the prints were easily removed intact. Some of the prints had been mounted with adhesive directly onto foam core or thick cardboard, in which case excess portions of the backing were cropped, but the prints were left mounted.

Each photograph bore a small label noting the year the subject in the photo received its award, as well as the name of various individuals or organizations responsible for that particular structure or location, such as its owners, designers, builders, creators, etc. Often these labels included a brief textual explanation of

the architectural importance of the award winner, and reasons why it was chosen for recognition. A large number of these labels were beginning to separate from the backing to which they were attached with adhesive; each was removed, photocopied onto acid free paper, and the copy filed along with the print it describes.
