Biographical Sketch

John W. Bluford III is a nationally recognized healthcare administrator with over 40 years of experience. Raised in Philadelphia, Pennsylvania and Columbia, South Carolina, Bluford attended Fisk University and Northwestern University before beginning his career as an epidemiologist at the Centers for Disease Control. His first hospital role was as a night administrator at Cook County Hospital in Chicago, Illinois. He soon moved to Hennepin County Medical Center in Minneapolis, Minnesota, where he served in various leadership roles – including CEO – for 21 years. While in Minneapolis, Bluford also led the Pilot City Health Center.

In 1998, John Bluford accepted the position of Executive Director and CEO of Truman Medical Centers (TCM) in Kansas City, Missouri. During his tenure at TCM,

Bluford worked to expand the physical presence of the organization, raise its profile as an efficient and modern healthcare facility, and increase community engagement and support. Bluford retired from this position in 2014 but has remained active in the professional field. He continues to serve as president of the Bluford Healthcare Leadership Institute, which he founded in 2013.

Among his many achievements, Bluford has served as Chair for the Missouri Hospital Association (2006), Greater Kansas City Chamber of Commerce (2007), National Association of Public Hospitals (2009), and the American Hospital Association Board of Trustees (2011).
